METRO MATCH RELATED DISPUTES PROCESS

Any complaints or disputes arising (including statistics, points and results) out of or in connection with any competition matches shall be made in writing on club letterhead, from the club involved, to Metro **no later than 72 hours** following the occurrence of the matter complained of or disputed. It is, however, the duty of every Captain in the first instance, before making an official complaint, to make every possible endeavour to resolve the matter with the opposing Captain before leaving the field of play in any match.

By way of clarification, the Code of Conduct regulations and disciplinary process (section 8) are considered separate from the match-related disputes process noted above.

In the event of a dispute between captains in a match without officially appointed umpires, this official is to be contacted.
