Background and Purpose

- Minimise, isolate, or eliminate (where possible) exposure to risk of all stakeholders in the Primary Winter Tournament
- Be transparent with insurers and obtain insurance rates at preferred rates.
- Ensure effective and efficient delivery of the event and its continued growth.
- Ensure safety of everyone associated with and involved in the event.
- Be a way for all key stakeholders to assess their own exposure to risk via this event.

Project Stakeholders

Stakeholders will assist in the monitoring of the risk action effectiveness and participate in the risk management reviews where necessary. This plan will be made available to them. The major stakeholders include, Primary Sports Canterbury, Participant schools, sporting bodies delivering activations, Christchurch City Council and venue/facility owners, participants and their whānau.

Risk Identification Process

Risk identification is a constant and ongoing process of identification, discussion, management, action and review. The identification process includes informal feedback from a variety of participants (entrants, spectators, volunteers, subcontractors) as well as formal reporting, which will include the following;

- The event management team
- Incident analysis
- Formal debrief sessions with key stakeholders
- Risk identification sessions
