- 10. Competition Structure -

Div 1 Women – Start 7<sup>th</sup> April - 1<sup>st</sup> Round – 1xRR, play-offs & finals = 7 weeks (based on Otum Steel included)

2<sup>nd</sup> Round – 3xRR, playoffs & finals = 11 weeks (allows for 2 rain-days)

Div 2 Women – Start  $2^{nd}$  April - 4 Teams -  $1^{st}$  Round – 2xRR, play-offs & finals = 8 weeks  $2^{nd}$  Round – 3xRR, play-offs & finals = 11 weeks

Div 1 Men – Start  $2^{nd}$  April – 7 Teams =  $1^{st}$  Round – 1xRR, finals = 8 weeks  $2^{nd}$  Round – 1xRR, semis & finals = 9 weeks

Baywide Men - Start  $2^{nd}$  April - 5/6 Teams - 1xRR, finals = 5 weeks - play Anzac, not Easter Baywide Women - Start  $2^{nd}$  April - 7 teams - 1xRR, finals = 5 weeks - play Anzac, not Easter Option of Marist Men might play in our TPL competition post Baywide

No objections for Otum Steel playing in the  $1^{st}$  round of Div 1, but cannot win the round – then move on to TPL competition
