Men's Feedback

Women's feedback

- Weren't happy with the accommodation. Shared bathrooms were not great.
- Expensive laundry fees

Thomas Makea – Wants to bridge that gap between NFC and U19s. Allow junior representative coaches to stand in at NFC trainings.

Women's NFC management team said there wasn't enough players to pick from. Women's lacked the mental skills was a key factor to their poor performances. Introduce mental skills approaches for our NFC players.

Both coaches wanted appointment process done after the season, this gives coaches an opportunity to organize some off season work for player working groups.

Hardship fund – Cut off by the end of next week. Will to speak to all teams, email out to clubs. Friday 16th December is the deadline

Auckland Softball Association Proposal

ASA is offering some sort of shared service agreement to smaller associations. This is to be discussed at the next executive meeting.

Auditors

Our auditors have resigned. N Jack explained that the cost of getting audits done is becoming more expensive (\$15,000). Our constitution says we need to have an audit, we need to think as to whether we want that clause in our constitution as under the new Incorporated societies act, it doesn't require us to do an audit. An alternative is having a high-level review done for specific areas of our finances (e.g., grant funding, and salaries). These reviews would be cheaper than having an audit done. Further discussions to be had.
