#### **INTER-CITY COMPETITION**

Nicole Jack advised the committee members of the on-going negotiations with Hutt Valley Softball Association for the Inter-City competition. # **VOICE OF PARTICIPANT SURVEY**

The Voice of Participant Survey was reviewed. The committee agreed that the information was indepth and requires a summarised version highlighting key aspects and recommendations for the clubs to assess and initiate procedures to improve the quality of the programs offered to the members.



### **OPERATIONS MANAGER REPORT**

The amendments in Inter-City Handbook are in progress, and once finalised will be circulated to committee members and affiliated clubs. The review procedure is conducted by Wellington Softball Association and Hutt Valley Softball Association.

The funding applications for the season 2021-22 are on hold due to Covid 19 pandemic and recent level 4 lockdown in Wellington. The funding applications will resume after the restrictions have been lifted. We will proceed with the planning of the 2021-22 season on the basis of the omission of funding.

The Netball Centre administration advised about the current restrictions in place in terms of accessing the office space and pavilion during and outside the usual work hours.

DW Dentice Ltd has indicated the budget of \$1400 for repairing of the lighting towers. The budget is an estimated indication and requires approval from the committee.

The clubs have been advised of the registration process and the staff is currently monitoring registrations, and further communication will be sent out to the clubs before the due date for pending registrations. Once the registration process is completed, draft draws will be created for review.

In terms of game development, Academy sessions has been cancelled due to Level 4 lockdown in Wellington. In the meantime, online resources and content has been circulated to the clubs. Plans are in place with Kelly Sports for in school programmes, contingent on the current and future restrictions in place.
