Currently, the 2021-2022 budget is recording a slightly high than expected profit due to a successful 2021 Otago Short Course Championship, however potential Covid interruptions may have an impact.

NZ Short Course Championship:

Disappointingly only one session was held out of the ten scheduled. Mary gave a recount of events on the day; watched the Government announcement on the big screen at the pool and within 20 minutes the 700+ competitors, their coaches and managers were on their way home, all of whom arrived home safely. Peter added that with the cancellation Swimming NZ won't be sending a team to World Short Course Championships in December. There is no coach willing to attend in the current Covid environment and attendance was to be self-funded. The 2022 Commonwealth Games are being held in Birmingham (United Kingdom), Swimming NZ to decide on attendance next year.
